#### Property Manager's Report, Dan Buccieri:

- Status on siding repair including costs. Complete until next summer. Several steeply sloping units will have steps addressed/repaired in the Spring. Railings to be added.
- Roofing Plan / Insulation proposal Jim Hallman, roofer, recommends starting with roofs with the most damage, usually due to the ice storm two years ago. Soffit vents will be addressed as well. Suggestion made that homeowners consider contacting RG&E, Monroe Gutter or Isaac to get an energy audit and add insulation as needed.
- One Step chemical application contracts extends into upcoming 2017 season. No price increase.
- Romig landscape contract continues in 2017 with modifications made to shrub pruning.
